### August 2024 Year-to-Date Report of 2023 LM-10 and LM-21 Non-Filers

#### **Introduction**

One of the key difficulties in tracking and understanding both prevalence and significance of union-busting, past and current, in the United States is the lack of filing by employers and persuader consultants who are required to do so by law. But this problem goes back at least forty years, as substantially documented by a 1984 House of Representatives Labor Subcommittee report, and reconfirmed by a recently released US Department of Labor Inspector General investigation.

The Office of the Inspector General¹ replicated the findings² of a 1984 Congressional Subcommittee on Labor–Management Relations which documented the existence of chronic underreporting of annual employer expenditures on persuader hiring (Form LM–10) and persuader annual reporting (Form LM–21). Significantly, both reached substantially identical conclusions regarding the primary cause of such underreporting: a severe lack of follow–through by the agency charged with the enforcement of such reporting, the (now) Office of Labor–Management Standards. Notwithstanding that such reporting may not be popular among employers and persuaders, it is still required by law, and unions are subject to similar annual reporting requirements which have changed significantly over the years, most recently in 2005, whereas the actual form of reporting for employers and persuaders has hardly changed at all.

Moreover, the 1984 Congressional Report documented a worsening imbalance between resources devoted by what is now OLMS to securing union reports in comparison with

resources devoted to employer and persuader reports. That imbalance is still operative today. While there are over 20,000 unions who must file annual financial reports and around 200 employers who must report persuader payments and a somewhat lower number of persuaders who must file the annual report, it is clear from current OLMS publications that the agency devotes considerable resources to ensure reporting compliance with unions. According to OLMS's 2023 annual report, OLMS completed 1,329 delinquency investigations of unions and boasted that they removed 652 unions from the "chronic delinquency watch list" (unions that file late for three or more consecutive years). OLMS does not disaggregate their data on "Special Reports", of which 100 were completed in FY 2023 because these include reports such as the LM-30, so we do not know the exact number of delinquency or deficiency investigations completed by OLMS on employers hiring persuaders or the persuaders themselves.

The recent Inspector General investigation recommended OLMS make a significant improvement in securing reports from non-filers, as well as improve its own internal complaint handling system about non-reporting.

Annual reports Forms LM-10 and -21, like their union annual report counterparts, are due ninety (90) days from the close of the reporting year. In 2022, LaborLab, a non-profit watchdog organization, created a quarterly spreadsheet of all LM-10's and LM-21's <u>owed</u> by a triggering LM-20 had been filed (our methodology section below describes this in substantial detail). These quarterly reports not only counted the number of LM-10s and LM-21s *owed but not* filed for 2022 but listed them and included hyperlinks to the triggering reports. These reports were shared with OLMS and sadly, we did not notice much improvement in the number of non-filers who finally did file their 2022 reports. It should also be noted that LaborLab routinely files complaints with OLMS of LM-10s and LM-21s that are not filed, delinquent, or deficient, and to improve our own ability to follow-up, we have now started numbering each complaint filed.

Because of the lack of progress in 2022, we decided to repeat the process again in 2023 and each May, August, November, and February, we repeat this analysis and will continue to supply it to OLMS. We should note several caveats here regarding annual reporting: first, we only include those reports for 2022 and 2023 that are filed for that particular year. On the other hand, OLMS, from what we can tell, reports total reports

filed each year regardless of which year they are filed for. Additionally, OLMS uses a fiscal not a calendar year; we use a calendar year. Finally, Form LM-10 can be used for multiple purposes, most notably to report employer payments to unions and union officials. For this reason, the total number of LM-10s filed in one year will not include just persuader reporting, but also reports of payments to union officials as well as payments for employee surveillance, persuasion, and employer unfair labor practices.

#### **Organization of this report**

In the following report, we briefly summarize our methodology and our findings for those employers and persuaders who owe but have not yet filed 2023 LM-10 and LM-21 annual reports. We then present our results in two attached spreadsheets, discuss these findings briefly, and conclude with a simple call to action from OLMS to fulfill its obligations under the law.

#### Methodology used

A key part of our methodology is the "triggering" device that requires a persuader to file an LM-21 and an employer to file an LM-10. All our data comes directly from the OLMS Public Disclosure online database.

What triggers the filing of a Form LM-21? There is little ambiguity regarding which employers and persuaders owe annual reports. As the instructions for these forms, the applicable regulations, the LMRDA, and compliance assistance materials published by the agency make abundantly clear, the mere filing of a single LM-20 by a persuader in their fiscal year triggers the filing of an LM-21 annual report for that fiscal year. Even under the 2016 OLMS Special Enforcement Policy, an LM-21 without any reporting of Part B receipts and Part C disbursements is considered an acceptable, although incomplete filing. Regardless of whether the persuader itemizes such receipts and disbursements, the LM-21 is still owed. As the attached spreadsheet illustrates, many of those LM-21s owed but not yet filed are from new consultants who have filed only one LM-20 for 2023. That does not absolve them of the requirement to file and for OLMS to secure copies of those filings. Nor does it remove the obligation for OLMS to contact those persuaders and secure their 2023 LM-21 filing.

Here, the LM-20 acts as a trigger, much the same way the filing of a Form LM-1 by a labor union triggers annual reporting by way of Form LM-2, -3 or -4. Unions must continue to file these annual reports after an LM-1 filing until they file a terminal

report. For the same reason, a persuader must file an LM-21 if they file just one LM-20 in any single fiscal year. It is just that simple: securing the filing of an LM-21 all persuaders should be a straightforward process for OLMS: find an LM-20, pull the name of the filer and all subcontractors listed in item 11, and make sure they all have filed an LM-21 for that year.

What triggers the filing of an LM-10? Likewise, the mere filing of an LM-20 within a given fiscal year also triggers the filing of an annual Form LM-10 by an employer. In practice, it may be more difficult to crossmatch LM-20s with LM-10s for a variety of reasons and having done it extensively for more than two years, we can speak from experience. The persuader may not have used the correct business name, and this is particularly true for the subcontractors listed on the LM-20. Secondly, a different business address may be used on the LM-10 than the LM-20. Nevertheless, with less than 200 LM-10s for persuader activity filed per year, in our experience, the vast majority can be easily crossmatched with the LM-20 and the remainder require some additional work which is doable. It should be noted that OLMS did earlier try to require Form LM-10 to provide an Employer Identification Number for easier identification and even the recent change in the Form LM-10 requiring the reporting of federal contracts requires the inclusion of the Unique Entity Identifier, which facilitates crossmatching.

How do we construct our database? Each week, LaborLab collects and examines every Form LM-20 filed with OLMS. This information is stored in a spreadsheet. Over the year, we accumulated a database of LM-20s. It should be noted that unlike union data, which can be downloaded easily on an annual basis, the same utility is not available on the OLMS Public Disclosure website, but we must stress that we are using the same publicly available information that OLMS has access to in all our following analysis.

How do we construct the spreadsheet of LM-10s owed? To generate a spreadsheet of LM-10 forms owed, we sort that database by employer name and secondarily by address; sometimes it is possible to do this by the OLMS-assigned report number, except that in many cases a second or even third LM-10 is filed, which will have a different reporting ID. From this listing, with comparison back to the triggering LM-20, we can determine who the prime contractor is so that there is only one record for each employer; the only exception are those employers who, contrary to the instructions, file a second LM-10 for the second prime contractor (they should all be

consolidated on the same form, with separate pages for different primary persuaders). This process ends in a filter list of unique reporting obligations which represents all LM-10 reports owed. Our next step is to identify those who have actually filed.

To do this, we use the Public Disclosure database and one-by-one search for 2023 filings by the specific employer. Note that by using the Public Disclosure database, we are getting the most recent filing data. Each quarter, we use the spreadsheet from the previous quarter and note any new filings that have come in since the previous report.

How do we crossmatch employers listed in LM-20s with LM-10s? In running this crossmatch, we use both the name and trade names given in the LM-20, and we often must work through spelling errors or incomplete listings. If we are not sure we have a valid crossmatch, we do not show the report as having been filed.

Where there is a crossmatch, we record the filing date of that 2023 report and insert into this date a hyperlink to the filing, so that OLMS (or any user) may simply click the hyperlink and pull up that report for verification. We also include a hyperlink to the triggering LM-20 so OLMS may verify the existence of the trigger.

*How do we construct a spreadsheet of LM-21s owed?* The process for extracting the LM-21s owed is similar but different in several regards. First, the LM-20 will record not only the entity filing the LM-20, but a list of all subcontractors hired in item 11. Since those subcontractors will have an obligation to file an LM-21, it is important to capture this information, and to do so, we must first clean up the data. We frequently find that subcontractors names and organizational affiliations, if any, are inconsistently spelled, which requires additional research and crossmatching. In some cases, no information about the subcontractors' organizational affiliation is not provided; some are sole proprietors, some have business names and at least one large persuader uses code numbers instead of organizational names (which is a violation of the instructions and has been brought to OLMS's attention several times). After cleaning up the data in this fashion, we then query the database to determine how many times each subcontractor is referred to in an LM-20, either as a contractor or subcontractor. After sorting the revised list alphabetically, we then go to the OLMS Public Disclosure web page and individually crossmatch to see if there is a 2023 LM-21 filing. If there is, then the filing date is recorded in the spreadsheet and a hyperlink to that filing is embedded in the filing date. This provides us with the most current and comprehensive reporting possible under the circumstances. The data in attachments 1

and 2 are current as of July 31, 2024. It is possible that between the time this report is read and then there will be new crossmatches, but we will repeat this analysis in November 2024 and February 2025.

We have offered to share our methodology and spreadsheets for performing the non-filing analysis with OLMS and we renew that offer, including our willingness to train OLMS staff in how to apply the methodology.

#### **Results**

Attachment 1 presents a spreadsheet on 2023 LM–10 non-filers and Attachment 2 presents a spreadsheet examining 2023 LM–21 non-filers. For 2023, there should have been 149 employers filing LM–10s for persuader activity (there may be more filed for reporting payments to unions and union officials, but these are not reported here). **As of 7/31/24, only 54 or slightly more than one third have filed their LM–10s, and the total expenditures are slightly over six million dollars,** which falls well below the estimates of 25–30 million dollars spent by employers for persuader activity each year. Ninety–five (95) employers have failed to file their LM–10s for 2023. There is a non–filing rate of 66% six months after the LM–10 forms are due (they are due 90 days from the close of the employer's fiscal year, but most fiscal years correspond to the standard 1/1 – 12/31 fiscal year).

As indicated earlier, the triggering LM-20 hyperlink is provided in column D of this spreadsheet so OLMS can easily confirm that an LM-10 is owed. It should also be noted that LaborLab has already filed delinquency complaints with OLMS on many, if not most, of these employers.

Regarding non-filed 2023 LM-21 reports, Attachment 2 reveals that as of the end of July 2024, **barely 40% of persuaders have filed their required report.** Many of the filings that have been submitted are also deficient, for reasons including being a partial year report (some persuaders file annual reports for several weeks or several months, not for the entire year as the instructions require) or incomplete information provided on subcontractors in Part D. As with LM-10s, we have already filed complaints with OLMS for many, if not most, of these deficiencies. We have also tallied the number of times each consultant shows up in an LM-20 in 2023, and from this many have low persuader activity, but *that does not excuse them from filing*. Additionally, many are sole proprietors with little business experience, but *that does not excuse them from filing*.

In conclusion, we ask OLMS to simply fulfill its obligations under the law. OLMS needs to devote at least the same effort and resources to securing non-filers from employers and persuaders that they do with unions.

We will continue to provide these quarterly reports to OLMS, so they may secure the required reporting from these employers and persuaders. The disappointing lack of OLMS response from 2022 and our first quarterly report for May 2024 requires we engage our stakeholders to increase scrutiny of this process. Our largest single stakeholder group, labor organizations, are already asking why OLMS focuses so much on union annual report filing and so little on required employers and persuaders reporting.
